Purposes of processing your personal data

Duration of storage

Your personal data will be stored at the HMGU Career Center for the time it its supplying its services to you and for a period of up to 6 month after you have departed the HMGU. After that your personal data will be deleted. If you withdraw you consent your personal data will be deleted immediately unless there is a legal obligation for the HMGU Career Center to retain the personal data.

Recipients of personal data

Your personal data will only be passed on to the persons involved within the career development process of the HMGU Career Center. Transfer to a third country

Your rights as a data subject
